#### 1.0 Purpose/Problem:

The purpose of this report is to provide information and a recommendation to the Parks and Recreation Committee regarding the use of Lions Park by the Boy Scouts of Canada for a Link Camp.

#### 2.0 Background Information:

- In April of this year, we received a request from the Boy Scouts of Canada (PoCo District) regarding use of Lions Park to form a Link Camp. A Link Camp consists of youths from 5-26 year old, involving 432 youths with 102 leaders.
- 2.2 The camp would run Friday evening until Sunday afternoon. The activities that would take place are as follows:
  - overnight camping on Friday and Saturday nights which would involve 300 people
  - campfires in two locations on Friday and Saturday evening with no open fires for roasting

#### 3.0 Other:

3.1 I have some concerns on whether it is a good idea to give any group exclusive use of Lions Park even though May is not one of our busy months.

- 3.2 The park's washroom facilities are inadequate for this type of event. The group has indicated that they will be supplying portable washrooms in the park. The other concern that I have is over the parking space that is available for this size of event. The Boy Scouts have indicated that they would have participants car pool together and suggest that people be dropped off for the weekend.
- 3.3 With the Boy Scouts organization doing the clean-up after the event, the cost factor to the Parks and Recreation Department should be nominal.
- 4.0 Summerry/Conclusion:

The Boy Scouts of Canada is a volunteer organization whose work in the youth area of the community is very worthwhile. The City's support behind this community event is very valuable and the benefits to the youth in our community is unmeasurable.

The Port Coquitlam Scouting District, Boy Scouts of Canada, wish to make application to the City of Port Coquitlam for the use of Lions Park to hold a "Link" Camp during the month of May, 1994 from a Friday night thru to mid Sunday.

A "Link" Camp, which is held every four years, consists of youth from all sections of scouting; Beavers 5 - 7 years, Cubs 8-10 years, Scouts 11-13 years, Venturers 14-17, Rovers 18-26 and various section Leaders and Advisors. The number of youth that would be involved in this camp could amount to approximately 432 youth with 102 leaders. As well as additional support staff.

These numbers account for: 170 Beavers, 45 Leaders

150 Cubs, 30 Leaders 80 Scouts, 20 Leaders 20 Venturers, 5 Advisors 12 Rovers, 2 Advisors

A "Link" Camp weekend would consist of Friday night camping under canvass for the senior sections (Scouts, Venturers and Rovers) with the Beavers and Cubs arriving Saturday morning for programs that are run throughout the day with the Beavers heading home in the early evening and the Cubs remaining to spend a night under canvas with the senior sections. This "Linking" allows the sections to work side by side, with the younger sections observing and working together with the older sections. This is a very important part of linking and peaking the interest of the younger youth to continue on in Scouting.

Lions Park area provides public visibility which we feel is very important for the Scouting program. We would like to invite the public on the Saturday to view Scouting at its more adventuresome if not its best. Past Link camps have been held in places not easily accessible to the public and not in the Port Coquitlam boundaries. We feel that in 1994 we would like to hold our Link Camp within these boundaries and demonstrate to peers and neighbours the many skills through participation and cooperation that youth in Scouting are being taught.

Scouting is well prepared to bring in port-a-potty's to accommodate these numbers and to transport out of the park any waste water from the cook house or camp sites if there is not a disposal area at the public washrooms. Like many of our camps this one will be a "no trace" event which the policy is "you must take out everything you bring in", including bagged garbage.

We are looking at the northern section of the park for the main camp of Scouts, Cubs and their leaders to set up their tents and the far southeastern corner for the Venturers and Rovers. The Cook house would be more than adequate for the cooking of the meals for the Beavers and Cubs. The Scouts, Venturers and Rovers would cook their meals at their campsites using propane or Coleman stoves. There will be no open fire cooking.

Saturday program would be run in various sections of the park and along the dyke on a rotating schedule for the youth.

In Scouting tradition we would ask permission to have designated areas for open campfires in two locations. One at the Venturer/Rover Campsite and another in the area of the Cubs and Scouts where our main campfire can be held on Saturday night. We would assure you that these would be "no trace" campfires and would be attended to at all times.

Scouting is a very worthwhile and rewarding program and your consideration and assistance in helping us to make Port Coquitlam's Scouting "Link" Camp a success would be very beneficial to the youth in our community.
