SUBJECT: PCAA - Request To Install Storage Facilities

Recommendation:

That the request received from the Port Coquitlam Amateur Athletic Association to install two or three steel storage containers be approved in principal as per their proposal, provided the City and PCAA can agree on locations for these containers.

Purpose/Problem:

The purpose of this report is to provide information and a recommendation regarding the request received from the Port Coquitlam Amateur Athletic Association to install two or three steel storage containers at two City recreation facilities.


Background Information:

Storage of equipment is a real problem for sport/service associations and department programs in Port Coquitlam. As a result, we have discussed this issue with PCAA on numerous occasions over the last several years. Each discussion has resulted in a similar conclusion that this issue is something that should be addressed each time we renovate or expand one of our facilities.

In the interim, PCAA has approached us with a proposal to install one or two steel storage containers at the Port Coquitlam Recreation Centre and one steel storage container at Centennial Pool. Exact location of the containers at these sites has not been discussed and will have to be agreed upon prior to final approval.




Although staff understand very well the storage issue, they do have several concerns that should be discussed regarding this proposal.

With PCAA continuing to expand their storage requirements, the issue of "me too" becomes a real potential problem. Several other organizations have already started to raise the issue of storage and we fear the vision of our facilities one day being "ringed" with temporary storage facilities. On the other hand, we do envision the expansion of the Port Coquitlam Recreation Centre at some point in the future and are therefore also reluctant to encourage any additional permanent storage structures to be constructed.

The second issue relates to the installation of the containers. Staff feel that if the containers are going to be set on concrete corner blocks, then some kind of pad should be prepared so that we do not have long grass growing out from the underside of the containers, thereby avoiding increased maintenance costs.

The third issue relates to a number of ideas currently being reviewed by the staff for this outside area at the Port Coquitlam Recreation Centre. It is unclear whether or not PCAA's proposal would in any way conflict with these program/service ideas.

Dear Larry:-

As you are aware from our monthly meetings and the minutes of those meetings we have an ongoing problem finding storage room for our member sports equipment. Our current facility is filled to overflowing.

We recently were granted a Casino licence by the Province and the event proved to be very successful.


We now have the funds to provide additional storage units and wish to work with the City to install two or three metal storage units at suitable locations in the City.

Our plan is to install a container (possibly two) in the area where our current storage facility is located. The type of container would be a remodelled shipping container which would be located on cement corner blocks only making them movable if required. This would be in keeping with the City's desire to avoid any permanent buildings at this time. We would also like to place a Container at the Centennial Pool to be used by the swim club and we understand part of it would be available for City use.

These containers would be modelled in the same manner as the surrounding city facilities and would be painted in whatever colors the City might request at our expense. The only assistance we would require from the City would be Access to electricity for heat and light which would be on separate meters which we be responsible for.

We hope that your Department will look favourably on this proposal and look forward to hearing from you in the near future.

SUBJECT: Art Productions Ltd. - Request for Free Use

Recommendation:

It is recommended that Art Productions Ltd. be granted one free use on November 15, 1992 at Hyde Creek Centre and that the Civic Events account be charged for this rental.

Purpose/Problem:

The purpose of this report is to provide information and a recommendation regarding a request received from Art Productions Limited for two free rentals at Hyde Creek Recreation Centre.

Background Information:

On September 20, 1992 Art Productions Limited had booked Hyde Creek Recreation Centre for an "Art and Silk Plant" sale from 7:00am to 5:30pm. Since this sale was booked in the Spring of 1992, we were not aware that the Terry Fox Run was scheduled for the same day. As a result, the space required by Art Productions Ltd. (gym) was available on September 20, 1992, but access would have been limited as a result of Laurier Avenue being closed during portions of the run. Parking would have also been a real problem.

We "caught" this problem approximately one week before the event and called the President of the company, Mr. Malone, to forewarn him. We explained the problem and offered to assist him with relocating the event to the Port Coquitlam Recreation Centre (Mabbett Room). He felt that it would be too difficult to properly notify people of the change of location and decided to cancel the event.

As outlined in his attached letter, he was able to pull the flyers before they were circulated, but did incur the cost of having the flyers printed (\$678.00). We returned his damage deposit and did not penalize him for the late cancellation of the event. Mr. Malone is requesting two free facility rentals as a way of compensating him for his inconvenience and expenses.

I would concur with Mr. Malone comments to me over the phone that we do have a responsibility to forwarn him of issues that may prevent access to the building at the time of setting up the contract. However, this presents a couple of problems for the department:

- 1) Staff in the Parks and Recreation office were not aware of the date for the Terry Fox Run when this contract was set up. The letter from the Kinsmen to the Mayor regarding this event was not forwarded to us until late August.
- 2) The Parks and Recreation Department does not authorize the closure of the roads for this or other events.


Loss of revenues incurred by the Department for the September 20, 1992 event were \$540.35. I feel that the City, as an organization, inconvenienced this gentleman and as a result should at least partially compensate him for his expenses by providing him with one free rental. Loss of revenues related to this solution should be charged against the civic events account so that the Hyde Creek Centre is not absorbing this additional loss.



Re: Art Productions " Art & Silk Plant Sale " that was booked last spring to be held in the Hyde Creek Center Sept/20 from 7am to 5:30pm. The City did not inform us that Laurier Ave. would be closed from 9am to 2pm due to the Terry Fox run, which would prevent our customers from driving to this location.

We were notified one week prior to our exhibition at which point we had our advertising printed (Circulars) and delivered to three area post offices. We managed to stop the postal stations from making delivery of our advertising but will have to absorb the cost of printing 25,000 circulars (\$678.00). not to mention our loss of potential sales.

We feel that in all fairness some compensation for our losses should be granted by the City of Port Coquitlum. We have another booking Nov.15th and will need two more dates in the spring at Hyde Creek Center. We propose that we be granted two more bookings at no charge at this facility.


Council has requested that this opening to provide access to the dyke be completed as soon as possible.


SUBJECT: Pitt River Road

Brent Sewell and Roger Forester of C.P.Rail were in attendance to discuss their usage of Lions Park on July 26, 1992.




