PARKS & RECREATION COMMITTEE

A meeting of the Parks & Recreation Committee was held in the Parks & Recreation Office on June 25, 1991 at 8:00am.

In attendance were Alderman Mike Thompson and Alderman Marg Gordon.

Also in attendance was K. Janna Taylor, Parks & Recreation Director.

Item No. 1 Ball Diamonds - McLean Park & Thompson Park

The Parks & Recreation Director outlined the problems at the colt diamond at Thompson Park and the main diamond at McLean Park. Homeowners adjacent to both ball diamonds have been complaining about foul balls going into their front yards. The situation is unsafe and should be corrected.

The Parks Superintendent has investigated a solution and also provided a costing. Both groups using the diamonds have been contacted and have been notified of the problem and the solution.

The money to cover the cost of the netting etc. will come from the park D.C.C. interest.

Recommendation

- a) That a report be taken to Council approving the erecting of netting at Thompson Park (pony diamond) and the main diamond at McLean Park.
- b) That the estimated cost of \$10,200 be taken from the park D.C.C. interest.

Item No. 2 Cedar Drive Pathway

The Parks & Recreation Committee reviewed a report from the Parks Superintendent regarding Judy Johnstone's fence.

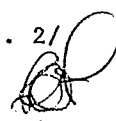
An onsite inspection was done with the Parks Superintendent and the committee members.

It was agreed that it would be appropriate to repair the broken planking on the fencing. It was also agreed to plant cedar hedging from Judy Johnstone's home along the pathway in front of her home to replace the fence that was rotting.

Recommendation

- 1) That the broken planks be replaced in the fence of Judy Johnstone's home.
- 2) That cedar hedging be planted along the pathway.

Recommendation

- 1) That no work be done in this area in 1991.
- 2) That funds would be included in the 1992 budget to accomodate Clematis Crescent landscaped median.

Item No. 5 1991 Schedule of Fees & Charges

The committee reviewed the report from the Recreation Manager. It was also noted that during budget discussion that the proposed 4% increase was discussed and agreed to.

Recommendation

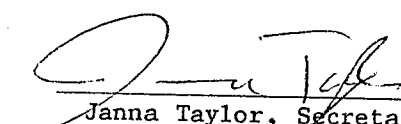
That the proposed 1991 fees be taken to Council for approval.

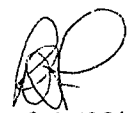
