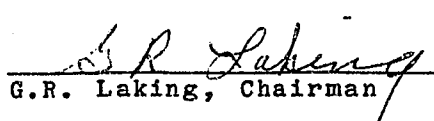
Recommendation:

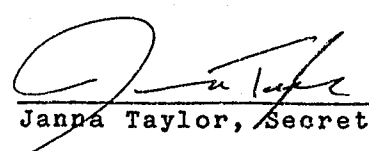
That the recommendations outlined in the Recreation Manager's report, except for the one to 50 ratio, be adopted.
