Item No. 3 Arena Roof

Comments

The roof at the old arena has been slowly deteriorating over the years. Large rust spots are covering the roof. These rust spots are becoming larger each year and of course eventually they will eat right through.

The other area of concern is the roof over the concession area; which is now leaking.

Attached please find a report from Tri-Plex who have given us an estimate of the cost of doing the repairs.

The question that must be addressed is; can we wait until next year to do the old arena roof? Under the present circumstances; (breakdown of equipment in Arena) it may be appropriate to delay until 1988.

However, I do not believe we can delay the work over the concession. It is presently leaking and should be repaired prior to the rains.

Recommendations:

- 1. That the built-up roof, over the main area of the concession, be repaired immediately.
- 2. That the administration committee be asked to find an account to provide the estimated \$7,400.00.

Item No. 4 District of Coquitlam - 1991 B.C. Summer Games

Comments:

The attached letter has been forwarded to the committee for action. Basically the District is requesting assistance in some way.

The area that we could assist, the District in, would be in providing such areas as; soccer fields, ball diamonds, outdoor swimming pool and lacrosse space. However, I do not believe we should provide staff time as this is a cost item.

SUBJECT:

Kinsmen's Proposal To Install A Temporary Sign

At Sun Valley Park

PURPOSE/PROBLEM:

To review and recommend an appropriate action regarding the attached letter received from the Kinsmen Club of Port Coquitlam requesting permission to install a sign at Sun Valley Park designating it as the future site of a water park.

HISTORY/BACKGROUND:

The Kinsmen Club of Port Coquitlam have received approval from City Council to construct a water park at Sun Valley Park, to open in 1988. Early in September, 1987, the Kinsmen Club plan to begin an aggressive fund raising campaign. They have requested that we assist them with their endeavors by granting them permission to place a sign at Sun Valley Park facilitating public awareness of the project.

Since signs are not normally permitted at this site, the Kinsmen have written to us requesting special consideration.

ALTERNATIVES:

Three possible alternatives are readily identified;

- a) refuse permission to erect a sign at Sun Valley Park
- b) give permission to erect a sign at Sun Valley Park

c) propose an alternate location

FINANCIAL IMPLICATIONS:

The extra costs incurred by the City as a result of having this erected would be negligible.

CITIZEN/PUBLIC RELATIONS INVOLVEMENT/IMPLICATIONS:

It is anticipated that the citizens would not object to having a temporary sign erected at Sun Valley Park. If anything, it would help create some community interest and help focus attention on the project.

OTHER:

It is felt that erecting the sign anywhere else but at Sun Valley Park would defeat the purpose of the sign.

This is an exciting project that will positively impact the quality of lives of the citizens of Port Coquitlam. Permission to erect a sign at Sun Valley would likely be interpreted as the City's continuing support of the project.

The sign is relatively high quality and has been professionally prepared.

CONCLUSION:

The Kinsmen of Port Coquitlam have approached the City to ask permission to erect a temporary sign at Sun Valley Park, promoting their project. Signs are not normally permitted at Sun Valley Park, so they are asking for special consideration. The sign is good quality and installation should not result in a great deal of criticism.

RECOMMENDATION:

That the Parks and Recreation Committee recommend to City Council, approval of this proposal.



Suject: Roof Recommendations & Costs Port Coquitlam Recreation Centre

We have inspected the metal roof system that is above the ice arena and the Built up roof area over the main entrance snack bar area. The following is our recommendations for the two roof areas:

Metal Roof Area: measures approximately 30,000 sq. ft.

- a. The surface of the metal roof must be prepared as follows:
 - all rusted areas are to be wire brushed & loose surfaces removed
 - all fasteners or bolts must be retightened
 - seams of roof projections are reinforced
 - all fasteners are waterproofed or resealed with neoprene cement
 - severely rusted through roof surfaces require patching
- b. Surface Protection:
 - A heavy-duty protection system is as follows:
 - all roof areas area sprayed with metal primer
 - all roof areas will have a coat of rubberized coating - application of aluminum coating as a reflective finish

As specified using Consolidated Goodyear products with inspections made by Mr. Rainer Maas, Consolidated, in order to receive the 10 year guarantee:

2% discount given if paid within 15 days of completion.

Snack Bar Roof Area: measures approximately 2,500 sq. ft.

We are recommending the following:

- removal of existing gravel, debris, & discard.removal of metal counter flashings and store for reinstallation.
- install one layer of recovery board.installation of new single ply membrane system.
- installation of patio stones.
- reinstallation of metal counter flashings.


