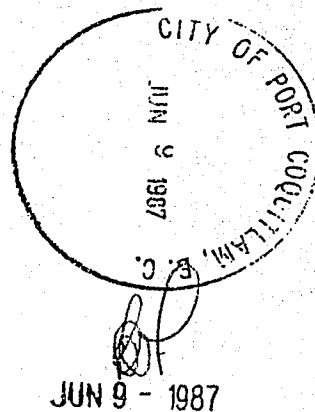
The Port Coquitlam Ringette Association has had another successful season and presently have six teams who have placed either first, second or third in the Provincial play-offs.



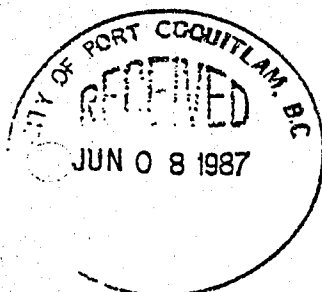
This seven year old youngster is asthmatic and is intensely allergic to alder pollen.

SUBJECT: Dates for 1988 May Day


Determining 1988 May Day dates, as soon as possible, is necessary to confirm tentative bookings for the ever-popular Ronald MacDonald show and the children's rides. Early bookings are required for popular parade entries such as the Shriner's units, the Vancouver Police Motorcycle group, etc.

- Mother's Day is May 8th (2nd Sunday of May)
- Mountain Festival in Maple Ridge is May 6th-15th with parade on May 7th
- Hyack Festival is May 20th-29th with the parade on the 28th.



Dear Sir:

The GVRD Parks Committee has recommended to the Board of adoption of a Regulatory Bylaw allowing the designation of Regional Park areas as "quiet areas". This designation would be applied in areas of special natural values or in crowded areas such as beaches, and would prohibit the playing of amplified music. The first areas where such a designation may apply is the White Pine Beach development on Sasamat Lake in Belcarra Regional Park.


We are soliciting input on this proposal and would welcome comments from your Council. As summer is fast approaching, we request that you respond at your earliest convenience.
