A meeting of the Parks & Recreation Committee was held in the Council Chambers on Tuesday, January 8th, 1986, at 4:00 p.m.

In attendance were Alderman George Laking and Alderman Mike Farnworth.

Also in attendance was K. Janna Taylor, Parks & Recreation Director.

CONFIRMATION OF MINUTES

That the minutes of the meeting of the Parks & Recreation Committee held on Wednesday, December 17th, 1985, be taken as read and adopted.

Item No. 1 PoCo Ringette Association

The Committee received the attached letter from the PoCo Ringette Association requesting permission to host the Provincial "B" Tournament. This tournament has been hosted by the association before and they have always done a good job. Committee recommended that the regular policy apply as in the Bantam Tournament.

- 1. That PoCo Ringette be authorized to host the B.C. Ringette Provincial "B" Tournament March 13th, 14th, 15th and 16th, 1986.
- 2. That all charges for room rentals be waived.
- 3. That ice costs be at 50%.
- 4. That the City operate the concession.
- 5. That the Ringette Association not sell similar food/drink items as that served in the concession.

Item No. 2 Cemetery

The Parks Superintendent submitted various recommendations to change the by-law. The Committee reviewed his recommendations (please see attached) and agreed in principle with them. It was suggested that Jan Fraser be invited to a Committee meeting to discuss the various proposed changes.

Recommendation

- 1. Opening hours:
 - a) April 1st to September 30th 8:00 a.m. to 8:00 p.m.
 - b) October 1st to March 31st 8:00 a.m. to 4:30 p.m.
- 2. Bicycles, tricycles and motorcycles be prohibited.
- No artificial flowers and/or potted container plants from April 1st to September 30th.
- 4. Ball games, golf, skateboards and kite flying be prohibited.
- 5. No alcoholic beverages to be consumed in cemetery.

Item No. 3 Garden Display - Expo

The attached letter was received from the G.V.R.D. The Committee discussed various possible locations.

Recommendation

That the parks superintendent be asked to design and cost out a pedestrian display for the grass area at the corner of Shaughnessy Street and Wilson Avenue.

Item No. 4 Welcome Signs

The aspect of having "Welcome to Port Coquitlam" signs installed at the entrances to the city was discussed at some length.

Recommendation

That the proposal for a Miss Port Coquitlam pageant not be part of the May Day Celebrations and that this recommendation be taken to Committee of Council.

General discussion took place on how the 1986 May Day celebrations would incorporate Expo. The possibility of having the Discovery Train in Port Coquitlam and also contacting C.P.R. for a possible display at the arena.

Recommendation

That Helen Fitch be asked to pursue the possibility of having the Discovery Train and a display by the C.P.R.

Several items that we would like to see placed on a sign on the cemetery are not covered in the cemetery bylaw and are creating considerable confrontations every time.

Opening hours should be April 1st to Sept 30th; 8.00A,M - 8.00 F.M

GENERAL

39. Cut flowers, wreaths, and floral offerings may be placed on any grave space in the cemetery but may be removed by the Caretaker when their condition is considered by nim to be detrimental to the beauty of the cemetery.

- 40. Boxes, shells, toys, wire screens, arbors and trellises are prohibited on any grave space in the cemetery.
- 41. No person shall plant, remove, cut down or destroy, any trees, shrubs, plants, flowers, bulbs or rocks in the cemetery other than an employee of the Corporation authorized to do so.
- 42. All persons are prohibited from damaging or defacing any memoria!, fence, gate, or structure in the cemetery, or any improvements in the cemetery.
- 43. No person shall enter the cemetery in a vehicle after sunset, or drive a vehicle in the cemetery at any time at a speed of more than 10 miles an hour, and all vehicles and their drivers while in the cemetery grounds shall be subject to the directions and orders of the Caretaker.
- 44. No person shall permit any bicycle, tricycle, dog or other animal within the cemetery grounds.
- 45. Owners of automobiles or animals shall be held responsible for any damage done by them within the Cemetery.
- 46. No person shall solicit orders for markers, tablets, memorials or like works within the limits of the cemetery.
- 47. All persons and funeral processions in the cemetery shall obey the reasonable instructions of the Caretaker, but any person not behaving with proper decorum within the Cemetery, or disturbing the quiet and good order of the Cemetery may be evicted therefrom by the Caretaker.
- 48. The discharging of firearms, other than in regular volleys at burial services, is prohibited in the Cemetery.
- 49. Any person who willfully destroys, mutilates, defaces, injures or removes any tomb, monument, grave stone, or other structure placed in the Cemetery, or any fence, railing or other work for the protection or ornament of the Cemetery, or any tomb, monument, grave-stone or other structure aforesaid or lot within the Cemetery, or willfully destroys, cuts, breaks or injures any shrub or plant, or plays at any game or sport or discharges firearms (save at a military funeral), or who willfully or unlawfully disturbs persons assembled for the purpose of burying a body therein, or who commits a nuisance, or at any time behaves in an indecent and unseemly manner, or deposits any rubbish or offensive matter or thing in a Cemetery, or in any way violates any grave, tomb, tombstone, vault, or other structure within the same, shall be guilty of an infraction of this Bylaw, and liable to the penalties hereof.
- 50. The Cemetery shall be deemed open at seven (7) o'clock every morning and closed every evening at eight (8) o'clock. Any person in the Cemetery without special permission of the Caretaker between eight (8:00) p.m. and seven (7:00) a.m. the following morning, shall be deemed guilty of an infraction of this Bylaw and liable to the penalties hereof.

- 51. Every person who violates any of the provisions of this Bylaw or who permits any act or thing to be done in contravention or in violation of any of the provisions of this Bylaw, or who neglects to do or refrains from doing anything required to be done by any of the provisions of this Bylaw, or who does any act which violates any of the provisions of this Bylaw shall be guilty of an offence punishable on summary conviction and shall be liable to a fine of not more than \$2,000.00 or to imprisonment for not more than six months, or to both, the penalties being enforced and the fines and costs being recoverable upon summary conviction in the manner provided by the Offence Act R.S.B.C. 1979, c. 305 as amended.
- 52. Notwithstanding anything herein contained, the administration of the Cemetery shall be carried out at all times in accordance with the "Cemetery Act" and regulations made thereunder.
- 53. The "City of Port Coquittam Cemetery Bylaw No. 820, 1966" is hereby repealed.
- 54. This Bylaw may be cited for all purposes as the "City of Port Coquitiam Cemetery Bylaw, 1972, No. 1192".

Dear Mayor Traboulay:

At its September meeting the Greater Vancouver Regional District Board of Directors unanimously approved a motion that member municipalities participate in a floral or garden display in 1986, to celebrate and promote Expo.

A committee composed of Mr. Jim Slater, Deputy Parks Superintendent, North Vancouver District; Mr. Ted Rathony-Reusz, Parks Director, Port Moody; Mr. Dave Mitchell, Registrar, B. C. Society of Landscape Architects and myself met recently to consider guidelines for the competition. The principal recommendation was that they be as flexible as possible.

These are the guidelines:

- The competition is among municipalities, the theme is Expo.
- There are two categories:
 - 1. pedestrian displays designed for viewing by pedestrians. They may be located at the municipal hall or in a public park.
 - 2. vehicular displays designed for viewing by vehicular traffic. Logical locations would be on major streets, at entrances to the municipality.
- Displays may be of a temporary or permanent nature.
- There is no regulation as to the actual size or extent of the display, but the size and resources of the municipality will be a consideration in judging.
- Municipalities may enter projects they were planning for 1986, whether or not this competition was held. However, it is hoped the competition will encourage them to do something special to promote the Expo spirit.
- One entry per municipality. The display should be in place for the duration of Expo, though it may
- be changed from time to time.
- Displays should be in place on May 2, 1986, opening day for Expo.

A panel of judges will be appointed to adjudicate the entries and a trophy or other suitable prize awarded to the winner and runner-up.

How will the entries be judged? That will be up to the judges, but factors such as originality, drama, action, night effects and color will certainly be considered.

The judges will visit the displays on several occasions. Winners will likely be announced in August.

We are hoping that all municipalities in Greater Vancouver will participate in this event. It is an opportunity to provide a colorful attraction in our communities and at the same time promote Expo.

We would appreciate knowing as soon as possible if your municipality plans to participate in the event.
