analyses have been undertaken, since 1910 for the different Branches of the Federal Service without any remuneration whatsoever, and more recently many examinations have been completed for the Customs Department under the Opium Narcotic Drug Act, and also for the Inland Revenue Department In 1912 I presented myself for examination as a Dominion Analyst before the late Dr. C. J. Fagan, in Victoria on two different occasions, and in each case no examination was held, although requested to attend such examinations by Dr. Fagan, he informed me in the first case after arriving in Victoria that the Laboratory was not equipped for the examination, and on the second occasion that the samples received by himself from Ottawa for the proposed examination were not in order.

Ottawa for the proposed examination were not in order.

My duties as City Analyst are wide and varied including the analyses of all food stuffs, drugs especially under the Opium Narcotic Drug Act, and all examinations for the Coroner and Police Departments, including human stomachs and contents, and other organs from the human body. blood stains, suspect rape cases, liquor cases, murder cases, etc, also inorganic examinations for the Engineering Departments.

The number of analyses conducted for the different departments in 1925 is as follows.

The Government of British Columbia appointed me a Provincial

The Government of the Onium Narcotic Drug Act.

The Government of British Columbia appointed me a Provincial Analyst to facilitate the enforcement of the Opium Narcotic Drug Act, this appointment was made in the interest of the Public.

In view of my qualifications and long years of experience, and the high reputation which the laboratory has attained throughout Canada and the United States, and the other matters which have already been touched upon, I feel that there will be no question in the minds of those in authority that I am entitled to be appointed a Dominion Analyst without salary, in the interest of the Citizens of Vancouver in the enforcement of the Adulteration Act, at the present time we have no authority under the Adulteration of Foods Act, and the work of the Food Inspectors and myself is seriously effected.

I am asking that an Order in Council be passed appointing me as a Dominion Analyst without the formality of an examination, and without salary, my qualifications, experience and my willingness to sit for examination on two different occasions is more than sufficient to justify this action. I am asking only the privilege of properly performing my duties as Analyst for the Corporation of the City of Vancouver, which privilege is denied me under the Adulteration Act which states that only a Dominion Analyst is qualified to examine foods etc, and proceed against the vendors of food stuffs which are adulterated.

to Ottain and by muts to Black

A Dominion analyst is now stationed in Vancouver, and is directed by the chief analyst at Ottawa, His duties are really concerned with imports and exports, and the examination of foods andfertilizers from Municipalities near Vancouver. The situation in Vancouver today is no different from what it was in 1911.

The City of Vancouver, with a staff of four food inspectors, constantly at work, and a large laboratory, is absolutely helpless in the matter of enforceing the pure foods act. No attempt whatever is made by the Dominion analyst or inspector in Vancouver to do the work that the city is doing, and if it were attempted, a staff equally as large as our own would be required to carry on this work.

The placing of a Dominion analyst in Vancouver, under Federal Control to do only such work as he is instructed to do from Ottawa, does not in the least effect our situation, what we require is authority to act (without salary) and proceed against those responsible for the adulteration of food stuffs,
